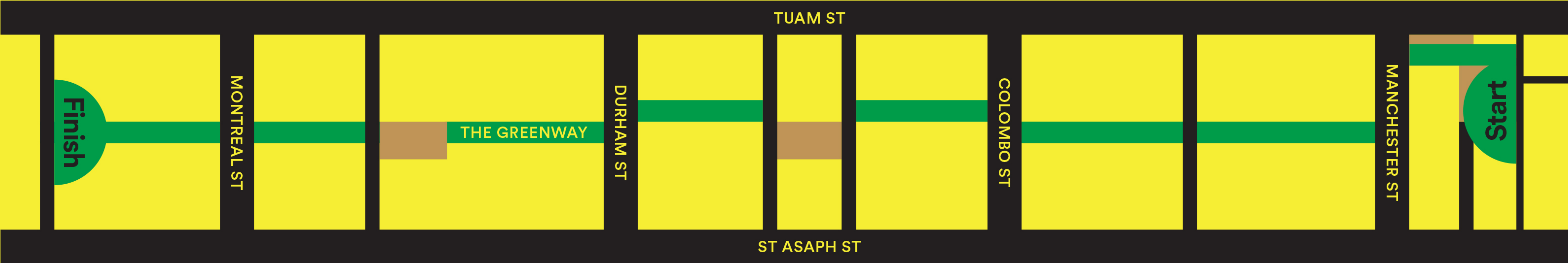


# South Frame Summer Scavenger Hunt
